The first party Late Sow. Kamaltai Jamkar Mahila Mahavidyalay, Parbhani and second party Hemant Nrityakala Mandir, Amravati is advanced in music subject and working towards skill development of students.

- The first party and the second party believe that there is cooperation and collaboration between them.
- This will encourage more effective interaction by everyone. Resources and enhanced opportunities for each of them especially alumni who are academically affiliated with the music department of the college.
- Both parties will cooperate and focus their efforts on cooperation in specific areas in the field of music.
- Both the parties being legal entities wish to sign MoU for the respective reason to impart basic knowledge training of professional Indian classical dance instruments to the students.
- Now in consideration of the mutual promises the fourth parols in this MoU are agreed as follows :

**CLAUSE 1
COOPERATION**

1.1 Both parties are united by shared interests and goals and will establish channels of communication and cooperation that will promote and advance their respective functions within the organization and its respective branches. The parties will inform each other of potential opportunities and share all information relevant to securing additional opportunities for each other.

1.2 Collaboration between the First Party and the Second Party will facilitate the effective use of the intellectual capacities of the First Party faculty and provide them with significant input in developing appropriate education systems, keeping in mind the needs of the Second Party.

1.3 Whenever possible, the students of the first party should be imparted the basic knowledge of dance art by the second party through online mode. Such participation by the Student shall be at the sole discretion of the First Party and the Second Party shall not in any way or manner require the participation of the Student as a matter outside of this MOU for the Student Experience.

1.4 Party No. 2 and Party No. of this MoU, 1 The availability of subjects (specimen) for research work in any of Dance, Instrumental Playing and Classical Singing will be at the discretion of Party No. 1. It shall be mutually decided by both the parties and shall be executed by the respective parties accordingly.

1.5 The General Terms of Cooperation shall be governed by this MOU. The parties shall cooperate with each other and immediately, as is reasonable and practicable, the agreements, acts

and documents (certain documents) necessary to give effect to the ideas contemplated in connection with this memorandum of understanding. The terms and conditions of the definitive documents shall be mutually agreed between the parties. Together with the definitive documents, this MOU shall represent the entire agreement with respect to the subject matter hereof and shall supersede the prior understanding of the parties hereto on the subject matter hereof.

CLAUSE 2

SCOPE OF THE MOU

- 2.1 Both sides believe that closer cooperation between the two will be important. It will be helpful for students to develop their sensibilities and acquire the knowledge to learn the techniques of Indian classical dance and instruments.
- 2.2 The Second Party shall provide valuable input to the First Party in developing the Dance and musical skills and will allow students to join online dance classes.
- 2.3 For association to build confidence and to prepare the students to have a smooth transition from dance and instrumental music for working career. That due to this Mutual agreement the students can expertise this field and also can make the same as their profession out of this knowledge and techniques.
- 2.4 Both Parties have agreed to carry out the joint experimental activities in the fields of Music by using the new techniques of Indian Classical Dance and Instrumental music.
- 2.5 Invited talks and subsequent discussions may be organized by first / second part to extend the necessary support to develop musical skill amongst students.
- 2.6 Both parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the program on the terms and specified herein.
- 2.7 There is financial commitment on the part of both the parties to take up any programme mentioned in the MOU. If there is any financial consideration, it will be dealt through proper process, if required.

CLAUSE 3

INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant implication, Estoppel or Otherwise, create in either party and right, title, interest, or License in or to the Intellectual property (including but not limited to know-how, inventions, patents and copy rights) of the other party.

CLAUSE 4

VALIDITY

- 4.1 This MOU/Agreement will be valid for 5 years until it is expressly terminated by either party on mutually agreed terms i.e. till breach of draft or till any point related to validation of the clauses.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.

CLAUSE 5

RELATIONSHIP BETWEEN THE PARTIES

- 5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as Independent contractors and the relationship established under this MOU shall not be Construed as partnership, neither party is authorized to use the other party's name in anyway, to make any representations or create any obligation or Inability, expressed or implied, on behalf of the other Party, without the prior written consent of the other party. Neither Party shall have, nor represent itself as having, any authority under the terms and this MOU to make agreements of any kind in the name of or binding upon the other party, to pledge the other Party's credit, or to extend credit

on behalf of the other party's.

FIRST PARTY

Any divergence or difference deprived from the Interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction In the Courts of Parbhani.
